Note-I:

### **The following procedure shall be adopted during Second Round of Counselling :-**

- Candidates, who have been allotted a seat in First Round of Counselling and have joined the allotted College /Institution shall be eligible to participate in this round of counselling and shall have to bring a copy of fee receipt deposited by them at their respective College / Institution for submission at the time of Upgradation/Allotment Counselling.
- Candidates, who could not participate in the First Round of Counselling for one or the other reason, are eligible to participate in this round of counselling.
- Candidates, who have opted CNA/SNA during the First Round of Counselling are also eligible to participate in this round of counselling.

- d. **The candidates, who have been allotted seat(s) in the First Round of Counselling but have failed to join the same within the prescribed time limit fixed by the Board shall not be eligible for participation in this round of counselling.**
- e. The candidates participating first time shall have to deposit the Counselling fee for Rs. 1000/- (Rupees one thousand only) through POS Machine available at the BOPEE office Jammu / Srinagar through Debit /Credit Cards. Any candidate who fails to deposit the counselling fee shall not be allowed to participate in the counselling process.
- f. The seat Matrix shall be uploaded on official website of the Board before the dates of counseling.

The other terms and conditions shall remain the same as notified in the e-Information Brochure and Notifications/Notices issued by the Board in this regard from time to time.
